

**The Terms and Conditions of admitting the Press accreditations for the  
UEFA Women's Champions League 2016/2017 round of 32 match between  
Medyk POLOmarket Konin and Brescia Calcio Femminile  
that will be played at Stadion im. Złotej Jedenastki Kazimierza Górskiego in Konin  
5<sup>th</sup> October 2016, 15.30**

1. The condition of receiving the accreditation is the registration through the Web page: [http://medykkonin.pl/index.php?tresc=dla\\_mediow](http://medykkonin.pl/index.php?tresc=dla_mediow), and accepting the Terms and Conditions.
2. The process of accepting application forms for the accreditation of the UEFA Women's Champions League 2016/2017 round of 32 match between Medyk POLOmarket Konin and Brescia Calcio Femminile, starts from the 20th of September 2016 till the 3th of October 2016. Application forms sent after 3th of October will be invalid.
3. Each User of registration system is obliged to give complete and true information.
4. Personal data is gathered and processed in the following registration system: [http://medykkonin.pl/index.php?tresc=dla\\_mediow](http://medykkonin.pl/index.php?tresc=dla_mediow). It will be used only by admitting the accreditations by KKKP Medyk Konin during the UEFA Women's Champions League 2016/2017 round of 32 match between Medyk POLOmarket Konin and Brescia Calcio Femminile.
5. Through the registration in: [http://medykkonin.pl/index.php?tresc=dla\\_mediow](http://medykkonin.pl/index.php?tresc=dla_mediow), the User confirms to process the personal data in accordance with 'The Personal Data Protection Act' 29.08.1997 (Dz. U. 133 poz. 833).
6. The administrator of the personal data of the registration system: [http://medykkonin.pl/index.php?tresc=dla\\_mediow](http://medykkonin.pl/index.php?tresc=dla_mediow), is KKKP Medyk Konin, ul.Podwale 1 in Konin.
7. The administrator is obliged not to reveal the User's data. The obligation by the law is the only exception.
8. The registered user can execute the rights set up by The article 32 from 'The Personal Data Protection Act', especially the right to view your own details, the right to update and cancel the details and the right to raise an objection in cases written in the regulations of that Act.
9. The decisions about admitting the accreditations will be sent to the e-mails given in the application forms in 24 hours after the registration.
10. Sending the application form does not mean that the accreditation will be admitted.
11. Accreditations will not be admitted to anyone under 18.
12. In case of resigning from the accreditation, we kindly ask to inform The Press Office of KKKP Medyk Konin through the e-mail: [media@medykkonin.pl](mailto:media@medykkonin.pl)
13. The accreditation is valid only with ID or passport.

14. The ACCREDITATION GIVES THE RIGHT TO ENTER the media working zone, the press tribune, the conference room, mixed zone and the stadium (according to the UEFA rules published in „Regulations of the UEFA Women’s Champions League 2016/2017”).

15. During the tournament, all media representatives have to obey the rules written in „Regulations of the UEFA Women’s Champions League 2016/2017”. The original of this document is available in the following address:

The rules concerning the media are included in Chapter XIII „Media Matters”.

16. Two days before the match the host KKPK Medyk Konin will send the detailed working conditions to the media representatives with accreditations.

17. In any other cases, the UEFA regulations also apply.

18. All media representatives have to make sure that during their work in the stadium area, the accreditation is visible to the security and staff of KKPK Medyk Konin.

19. Everyone with accreditation during the UEFA Women’s Champions League 2016/2017 round of 32 match between Medyk POLOmarket Konin and Brescia Calcio Femminile, who works in the stadium area, has to follow the instructions of the press officer, or people nominated by him, and of the security.

20. The accreditation can not be passed to the Third Party. If that happens, the accreditation will be invalidated.

21. The KKPK Medyk Konin has the right to invalidate the accreditation in case of not following the above regulations, the stadium regulations and the regulations set up by the sports federations applying to the media.
